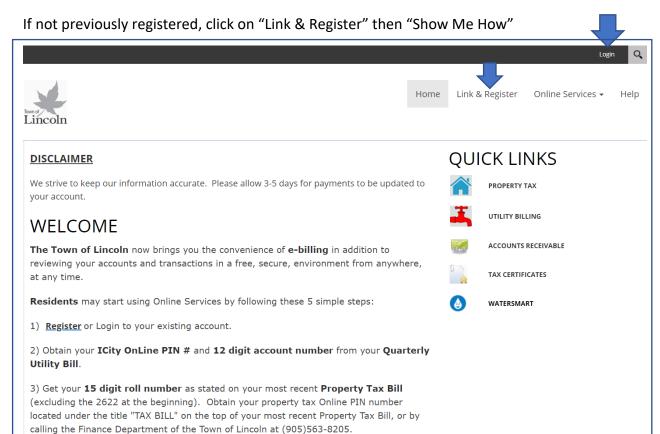
How to Register for E-Billing/Online Accounts for

Property Taxes

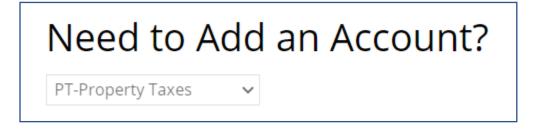
Go to www.lincoln.ca/onlineaccounts or open the below link:

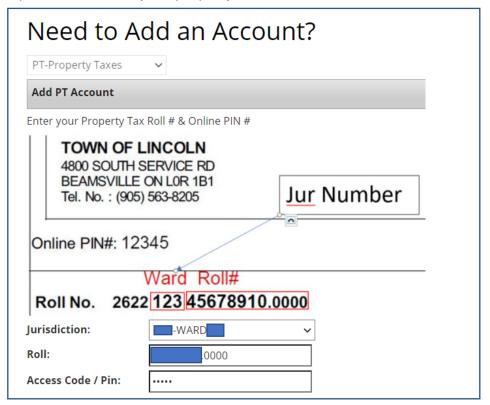
Already registered with online accounts? Click on Login



Under Account Management, you need to "Select Account Type" PT-Property Taxes from the drop down list.



Choose the Account Type PT-Property Taxes, then enter your roll number and 5 digit pin number from your property tax bill.



Next, tick off the boxes or bubbles based on how you wish to receive the bill. You will no longer receive a printed bill in the mail after you complete this next step.

Enter your email address and click "Send Verification Email".



Stay on this webpage while checking your inbox for an email from the Town of Lincoln.

The email will have the 6 digit Verification Code required above – enter this number within 15 minutes and click "Save". See sample email below:

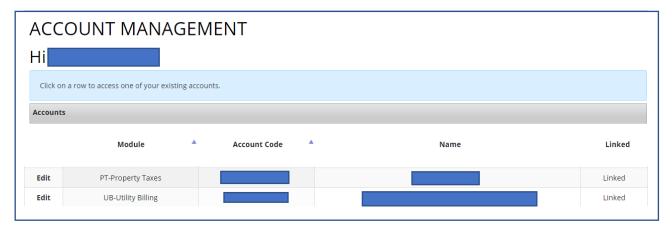

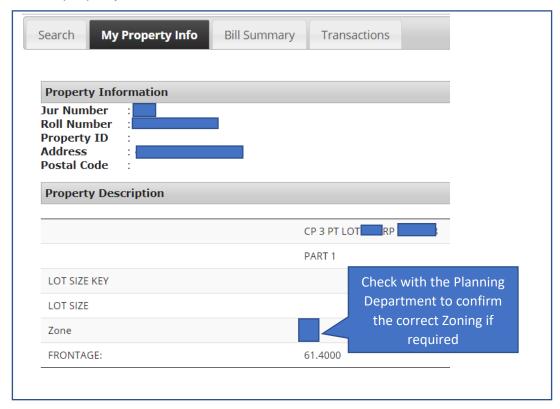
ACCESS TO ON-LINE ACCOUNTS

You will also have the ability to View your bill in detail, Summary or see your Transactions. Click on the row in your Account Management list to access your account information.

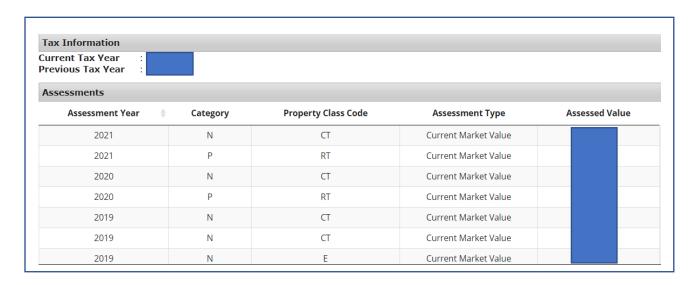


Next click on the tabs for "My Property Info", "Bill Summary" or "Transactions" in your online account.

Scroll down and find your Tax Levy Information and Assessment information. For questions regarding your assessment, please contact MPAC at www.mpac.ca.

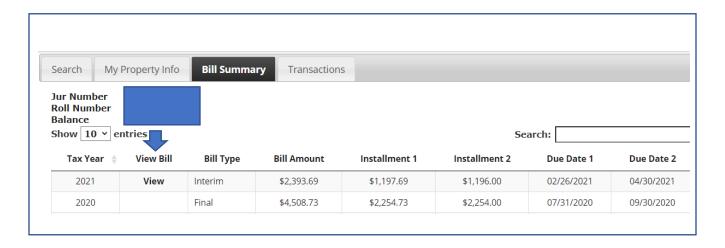


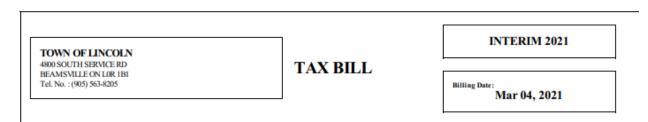
Current Tax Year includes only the tax levies that have been charged so far – it may not be the total for the year.

Category is your education support (P=Public, S=Separate, N=No Support specified).

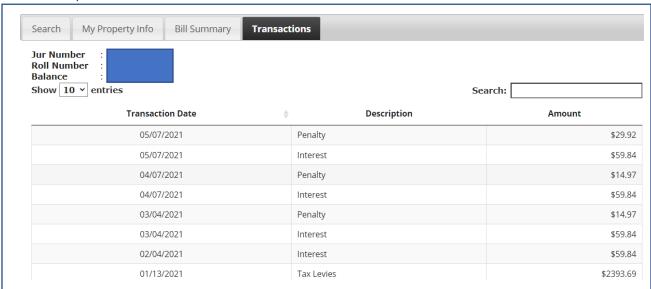
Property Class code is CT for Commercial Taxable, RT for Residential Taxable and E for Exempt in the above sample.

To see your previous Billing history, click on "Bill Summary". After you register for ebilling you will have access to your previous bills under "View Bill" just click "View" and a copy will display on your screen.





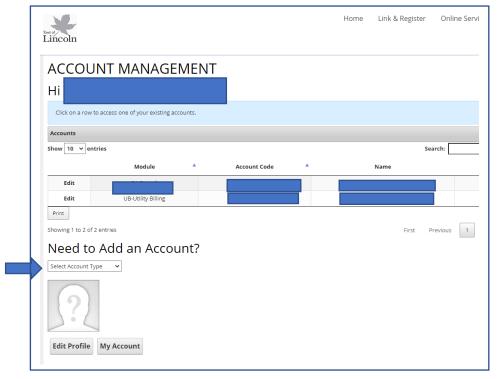
To view your Transaction History including tax levies, penalties, interest and payments in detail, click on "Transactions".



To exit, Logout or close "X" your internet browser.

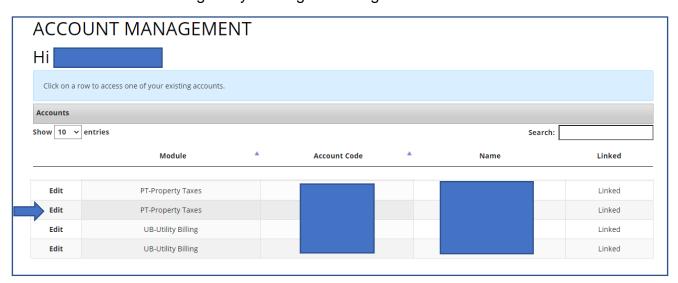
Multiple Accounts
