## Annual Road Resurfacing and Rehabilitation Program

### Project Description

Tentative Start Date: **April 2024 (weather permitting)**

Estimated Completion Date: **June 2024 (weather permitting)**

The Town of Lincoln's road network is a municipal core asset, supporting the economic, social and environmental health, as well as the growth of the community. The annual renewal program aims to be proactive with improving and maintaining the Town's overall road condition level of service. Pavement preservation and resurfacing strategies focus on "keeping the good roads good" and can include hot mix asphalt paving, crack sealing, and surface treatment (tar and chip) as well as other resealing application types. Pavement preservation and resurfacing treatments extend the service life of the road, helping to delay the need for more costly rehabilitation work in the future.

### Project Background

#### Hot Mix Asphalt Resurfacing

**Glen Elgin Drive, Butlers Walk, Nineteenth Street from Glen Road to the top of the hill, and Seventeenth Street from King Street to the top of the hill,** have been selected this year to be resurfaced with new hot mix asphalt.

Roads that are selected are specifically based on resurfacing and pavement preservation needs. Any Town road that requires underground watermain or sewer upgrades is not selected for resurfacing under this program since resurfacing of those roads will fall under a larger capital infrastructure project.

The Town publicly tendered the Road Resurfacing and Rehabilitation Program in March, and the contract was awarded to Associated Paving and Materials Limited.

## What to Expect

- All updates on this project will be made on the Town's website (shown below).
- Roads will be closed during construction and reopened at the end of each day. Access for local traffic, garbage collection, and emergency services will be maintained.
- In preparation for the work, the contractor will call for 'locates' and coloured spray paint will be placed in the right-of-way, marking existing utility locations.
- During construction, residents may notice dust, noise, and debris within the right-of-way.
- While construction is underway, street parking may become temporarily unavailable. Every effort will be made to ensure street parking is available at the end of each day.
- If your driveway will be impacted by construction, you will be contacted by the contractor within 24-48 hours of work taking place at your driveway.
- Sod boulevard areas may be disturbed during construction activities and will be reinstated as part of this project. The Town also monitors all disturbed locations during a one-year maintenance period where the contractor is obligated to repair any deficiencies.
- **Please mark all fixtures in the Town's right-of-way such as invisible fences, sprinkler heads, irrigation system lines, etc. The Town will not be responsible for unmarked fixtures.**

## Proposed Work Stages

Work phases include milling off existing asphalt, completing concrete curb replacements at specific areas, manhole and catchbasin adjustments, followed by the placement of a new hot mix asphalt layer, sod restoration (in impacted areas) and line painting. We appreciate the patience of our residents during all construction phases.
