BY-LAW NO. 18-29

A BY-LAW TO AMEND BY-LAW NO. 02-24, BEING A BY-LAW TO REGULATE POSTERS AND SIGNS ON PUBLIC PROPERTY AND ROAD ALLOWANCES

WHEREAS, section 11 of the Municipal Act authorizes municipalities to pass bylaws respecting signs;

AND WHEREAS it is deemed necessary to amend by-law 02-24.

NOW THEREFORE, the Council of The Corporation of the Town of Lincoln hereby enacts as follows:

- 1. That By-law No. 02-24 is hereby amended attached as Appendix A.
- 2. Appendix A, attached hereto and forming part of this By-law, is hereby appended as Schedule "D" to By-law No. 02-24, and shall be deemed to be part of that by-law.
- 3. This By-law shall come into force and effect on the date of final passing.

- 3.3. A Temporary Sign for which a permit has been issued shall be removed on or before the day following the expiry date of the permit.
- 4. REMOVAL FEE FOR UNLAWFULLY ATTACHED, PLACED OR DISPLAYED SIGNS OR POSTERS
- 4.1 Removal fee for Posters and Signs with an Area of Sign less then 0.6 square metres (\$50) fifty dollars.
- 4.2 Removal fee for signs with an Area of Sign greater then 0.6 square metres (\$200) two hundred dollars.
- 5. <u>PENALTY</u>
- 5.1 Any person who contravenes any provision of this By-law is guilty of an offence and upon conviction shall be liable to a fine of not less than \$250.00 and the maximum fine shall be in accordance with the provisions of the Provincial Offences Act, or other applicable statue.
- 6. EXEMPTIONS; GENERAL PROVISIONS
- 6.1 Municipal, Regional, Provincial and Federal Election Signs.
- 6.2 Signs for which permits have been issued prior to the coming into effect of this by-law by The Corporation of the Town of Lincoln, the Niagara Escarpment Commission, The Corporation of the Regional Municipality of Niagara or the Ministry of Transportation.

## Schedule "D" to BY-LAW NO. 02-24 BEING A BY-LAW TO REGULATE POSTERS AND SIGNS ON PUBLIC PROPERTY AND ROAD ALLOWANCES IN THE TOWN OF LINCOLN

- 6. Exemptions: General Provisions
  - (6.1) Signs for which permits have been issued prior to the coming into effect of this By-Law by the Corporation of the Town of Lincoln, the Niagara Escarpment Commission, The Corporation of the Regional Municipality of Niagara or the Ministry of Transportation.
- 7. Interpretation and Application:
  - (7.1) This By-Law gives the authority to remove any sign that is in contravention to the Municipal Elections Act as described in sections 88.2 (4), 88.3, 88.4 and 88.7 respectfully.
  - (7.2) Nothing in the By-Law shall be interpreted in such a manner to exempt any person from complying with any requirement or applicable law that may be in force from time to time in the Town or from observing or complying with the requirements of any applicable Federal, Provincial or Municipal legislation.
