

# IMPLEMENTING MUNICIPAL ACCOMMODATIONS TAX (MAT) ON AIRBNB LISTINGS

## **INTRODUCTION**

The Town of Lincoln is introducing a Municipal Accommodations Tax (MAT) effective July 1, 2024. This tax applies to short-term accommodations, including those listed on Airbnb. As a local short-term accommodation operator, it's essential to comply with this new requirement. This guide provides detailed steps to help you implement the MAT on your Airbnb listings.

## SUMMARY OF THE MAT PROGRAM IN THE TOWN OF LINCOLN

The Municipal Accommodations Tax (MAT) is a tax applied to the cost of accommodations provided for a continuous period of less than 28 nights. The revenue generated from the MAT will support tourism development and other community projects within the Town of Lincoln.

## Key Points of the MAT Program:

- Effective Date: July 1, 2024
- Tax Rate: 4%
- **Applicability:** All short-term accommodations, including those listed on platforms like Airbnb, provided for stays less than 28 nights.
- **Collection:** The tax must be collected by the accommodation provider from the guest at the time of booking.
- **Remittance:** Collected taxes must be remitted to the Town of Lincoln according to the prescribed schedule.

## STEP-BY-STEP GUIDE TO ADD MAT TO YOUR AIRBNB LISTING

- 1. Log into Your Airbnb Account
  - Open the Airbnb website and log in with your credentials.
- 2. **Opt-in to Professional Hosting Tools** 
  - Navigate to your account settings.
  - Find and opt-in to "Professional Hosting Tools" if you haven't already.
- 3. Select the Listing You Want to Edit
  - Click on "Listings" from the menu.
  - Choose the specific listing where you want to add the MAT.
- 4. Access Listing Preferences
  - o Under the Listing editor, click on "Edit preferences."
- 5. Add a Tax
  - Click on "Taxes" and then tap "Add a tax."
- 6. Enter Tax Information
  - Tax Type: Choose the appropriate tax type from the dropdown menu.
  - **Type of Charge:** Select how the tax is charged (e.g., per night, per stay).
  - **Amount:** Enter the MAT rate as specified by the Town of Lincoln.

#### 7. Provide Tax Identification Number

- Enter the municipal tax identification number: **202368** in the accommodations tax registration field.
- If you have a business tax ID, add it as well.

#### 8. Exemptions for Long-Term Stays

- Indicate whether your region provides an exemption for long-term stays (typically stays longer than 30 nights).
- If you choose "Yes," provide any additional required details.

#### 9. Agree to Terms and Save

- Review the terms and conditions.
- Click "Save" to apply the changes to your listing.

- **Stay Updated:** Keep an eye on updates from the Town of Lincoln regarding any changes to the MAT program.
- **Record Keeping:** Maintain accurate records of all tax collected and remitted.
- **Guest Communication:** Inform your guests about the MAT during the booking process to ensure transparency.
